

The Payment Application Data Security Standard (PA-DSS) is the current standard for payment applications that store, process, or transmit electronic credit card data. Entities benefit from the use of certified PA-DSS apps by reducing the scope of their own PCI assessment and mitigating the risk associated with developing a payment application.

PCI Software Security Framework (SSF) is an evolution of PA-DSS which provides validation programs for both the applications and the Software Life Cycle necessary for the secure design and development of payment applications. The SSF program breaks down into two separate certifications: the Secure Software standard and Secure Software Lifecycle (SLC).

In order to be PCI DSS compliant, your organization must adhere to **Requirement 11.2:** "Run internal and external network vulnerability scans at least quarterly and after any significant change in the network. Quarterly external scans must be performed by an Approved Scanning Vendor (ASV)." We start by configuring a custom PCI portal for your company to conduct ASV scans and generate your Self-Assessment Questionnaire (SAQ) report, if needed. Once the portal has been activated, a MegaplanIT security consultant will walk you through using the portal and provide you with recommendations for conducting and understanding the results of your first scan.
